SUBJECT: Approval of Tender: Re-Roofing at Stephen Public School and Mitchell District High School

1.0 Background

1.1 As part of the ongoing infrastructure improvements to be funded through Ministry capital funding, a tender was let for re-roofing at Stephen Public School and Mitchell District High School.

2.0 Project

2.1 Stephen Public School

2.1.1 This project is to install a cap sheet on the entire roof and replace approximately 110 sq. ft. of wet insulation. The project was advertised with six contractors receiving drawings and specifications. The following five prices were received.

Smith Peat Roofing	\$221,383.95

2.1.2 The Board's architect consultant, Marklevitz Architects Inc., recommends that the low contractor, Smith Peat Roofing & Sheet Metal Limited, be awarded the contract in the amount of \$221,383.95.

2.1.3 The recommended tender amount is less than the estimated budget amount for this project including fees of 4.5% to Marklevitz Architects Inc.

2.1.4 This project will be funded through School Condition Improvement funding. Attached is the recommendation from the Board's Consultant, which Administration supports.

2.2 Mitchell District High School

2.2.1 This project is to re-roof the cafeteria and tech wing of the school. The project was advertised with six contractors receiving drawings and specifications. The following five prices were received.

- 2.2.2 The Board's architect consultant, Marklevitz Architect Inc., recommends that the low contractor, Semple Gooder Roofing, be awarded the contract in the amount of \$269,906.15.
- 2.2.3 The recommended tender amount is less than the estimated budget amount for this project including fees of 5.5% to Marklevitz Architects Inc.
- 2.2.4 This project will be funded through the School Condition Improvement funding. Attached is the recommendation from the Board's Consultant, which Administration supports.

3.0 Recommendation

It is recommended that

the Avon Maitland District School Board accept the tender from Smith Peat Roofing & Sheet Metal Limited for cap sheet installation at Stephen Public School in the contract amount of \$221,383.95 and Semple Gooder Roofing for re-roofing at Mitchell District High School in the amount of \$269,906.15.




