SUBJECT: Approval of Tender: Cafeteria Upgrades at St. Marys DCVI

1.0 Background

- 1.1 As part of the ongoing infrastructure improvements to be funded through Ministry facility grants, upgrades to the cafeteria at St. Marys DCVI were identified. Work includes replacement of windows, exterior doors with accessible features, and lighting. Also included in this project is exterior walkway upgrades.
- 1.2 An electrical project which involves upgrading the power distribution at this school has already been tendered and approved. Separation will be coordinated with these two projects.

2.0 Project

2.1 St. Marys DCVI

- 2.1.1 Seven contractors received tender packages. One contractor did not submit and one was declared informal. The following 5 prices were received.

- 2.1.2 Marklevitz Architects Incorporated recommends that the low bidder, Elgin Contracting & Restoration Ltd., be awarded the contract in the amount of \$195,490.00.
- 2.1.3 The recommended tender amount is less than the estimated budget amount for this project including fees of 12% for Marklevitz Architects.
- 2.1.4 This project will be funded through School Condition funding. Attached is the recommendation from the Board's Consultant, which Administration supports.

the Avon Maitland District School Board accept the tender from Elgin Contracting and Restoration Ltd. for cafeteria upgrades at St. Marys DCVI in the amount of \$195,490.00.


